CRF = Assist for faster clearance of the goods in Uzbekistan Customs

\*PSIC = exporter's bank negotiation, if LC requires.

### 4. INSPECTION FEES:

- (1) Inspection fee to be borne by the Buyer (Importer) or by the Seller (Exporter)
- (2) OMIC may also invoice the Seller directly in such cases as the second inspection visit due to failure / unsatisfactory result of the first inspection or abortive visit.
- (3) The arrangement costs for presenting the goods for inspection such as handling, testing, unpacking, re-packing, sampling, etc. are for the Seller's account.

### 5. LIST OF GOODS SUBJECT TO PSI

PSI is voluntary, and maybe considered at the discretion of Banks and Importers/Exporters, when deems necessary

#### 5.1.LIST OF PROHIBITED GOODS:

All media deemed to be detrimental to the State and public system, in violation of territorial integrity, political independence and state sovereignty, advocating war, terrorism, violence, xenophobia and religious intolerance, racism in all its form and pornographic materials are prohibited to be imported into Uzbekistan.
